- 4. IT Update, we are still holding on the development schedule. Training could be possibly held up on a personal basis, but the training will take place on-line, but that will slow things down. Possibly a one month delay. Still on track to be converted over by February, but there could be a cost savings due to less travel costs.
- 5. BOD Elections. - 10. Motion to accept the Audited Fiscal statements and that they can be posted.
