

NSSA YOUTH CAMP GRANT

The National Skeet Shooting Association (NSSA) Youth Camp Grant Program is designed to support NSSA member clubs in hosting organized youth skeet camps that focus on instruction, safety, and skill development. Grant funds are intended to help offset costs directly related to conducting the Youth Camp, including instruction, targets, ammunition, and other approved training expenses.

Clubs are welcome to host an NSSA Youth Camp and may request funding to assist in hosting the event. Please submit this form if your club is planning to host a Youth Camp. NSSA will review the request and notify the primary contact regarding approval.

Youth Camp grants may be awarded as follows:

- **One-day clinics:** eligible to receive funding of **up to \$500**
- **Two-day clinics:** eligible to receive funding of **up to \$1,000**

For clubs hosting an NSSA Youth Camp for the first time, please contact NSSA Chief Youth Instructor Doug Thompson at easyskeetllc@gmail.com to possibly assist with your Youth Camp.

Youth Camp Club Requirements:

1. A minimum of 10 participants is required.
2. At least one NSSA Level 1 (or higher) Instructor must be involved.
3. The hosting club must be a current NSSA member club.
4. NSSA Youth Camps are designed to focus on skeet shooting only, with no other disciplines included.
5. Complimentary Limited Memberships (CLMs) will be provided to youth participants who are not current NSSA/NSSCA members.
6. A W-9 Form or Tax ID is required (if not already on file).
7. Within 30 days of completing the Youth Camp, the hosting club must submit all receipts for grant processing. NSSA will reimburse upon receiving receipts.
8. The hosting club must submit a brief summary and photos for potential inclusion in *CTN Magazine*, highlighting the event and the impact of the Youth Camp Grants.
