Dates to Remember

April 23 – Deadline date for members to get Director nominations to NSSA.
 As soon as practicable after **May 1**, NSSA will email ballots to all members in states/provinces eligible to elect Directors. Members may request a paper ballot beginning May 1. Any member who has not received a ballot from headquarters by **June 30** must notify headquarters for a replacement ballot to be mailed,

faxed or emailed in sufficient time to meet the return deadline. **Ballots must be returned to headquarters by midnight June 30.** Ballots may be returned by fax to 210-688-3632.
July 1 – Count Director ballots and determine winners. New Directors' term will begin on January 1, 2021. New Directors may attend annual Directors meeting in a non-voting capacity.
